## TOURNAMENT RULES

The following are the official rules and regulation of the Pioneer Valley Bowling Senate Doubles Tournament will be held two (2) big weekends, with entry closing on Sunday **August 3 2025 at 4PM. Walk-ins will be accepted.**

### 1. Eligibility:

- a) Shall be sanctioned and governed by rules of USBC and TNBA; and shall be open to all sanction members of USBC and TNBA for the **2024-2025** season. Non USBC members may enter by paying an unattached membership fee: Adult-National, USBC \$27.00 fee. Non TNBA members may enter by paying \$25.00 TNBA membership fee.
- b) **All bowlers shall present their membership cards or proof of membership before entering this tournament.**
- c) All bowler is required to report any previous tournament prize winning of **\$600.00** or more in the previous 12 months. (Rule 319d).

### 2. Entering Average;

- a) All participants must use the highest **2024-2025** USBC final average minimum of 42 games.
- b) Bowlers with no average for the **2024--2025** season will use their highest current average base on 42 games or more for the **2024--2025** seasons. . Bowlers with no average must use an average of **220. No summer average.. Ten-pin average rule does apply to tournament average.** Local association average book will be considered official for average verification or Bowl.com., as of the result to your average as of **January 1, 2025**
- c) **Average adjustment/re-rating: Bowlers shall familiarize themselves with USBC Rule 319E. Rule 319E will apply to all participants.**
- d) The tournament director reserves the right to re-rate any participant prior to bowling, or after a series (Rule 319 C 1-2). If the re-rated average is not accepted by the bowler, the entry fee shall be returned

### 3. It shall be the bowler responsibility to verify the accuracy of his/her average, whether submitted by the entrant, their partner or others. Failure to use the proper average or make corrections prior to the completion of the series shall disqualify scores bowled. If the submitted average is higher than the bowler's actual average, prize winnings will be based on the submitted average (USBC rules 319a, 3, 4). There will be no return of funds on disqualification.

All teams will bowl three (3) games on the same pair of lanes with total pins plus handicap determining the winners. Handicap in this tournament will be 100% and shall be based on the difference between the team averages.

4. Bowlers may re-enter as often as they like, but will only place once with the same partner. (USBC rule 315). Should a tie occur for first place, after all teams have completed the final squad **August 3, 2025**, at 4:00 PM, the two teams will split first and second place money.
5. Prize fund returned 100%. Prize ratio will be one (1) for all eight (8) teams entered. Cash prizes will be awarded in accordance with standing.
6. Entry fee: \$70.00 per team (\$35.00 per person). **No personal checks accepted.** We will accept cash, Venmo, Cash app, Bank checks, money orders or senate checks. Make check or money order payable to Pioneer Valley Bowling Senate.
7. **Singles are optional (Hdcp / Scr.) a bowler can only cash once on the prize list for position standings. (Hdcp. / Scr.)**
8. The tournament director reserves the right to disqualify any entry not in compliance with the rules of **TNBA/USBC**. The decision of the tournament committee shall be final on any and all disputes that may arise from technicalities which may have been omitted by the standing rules unless an appeal is made in accordance with. (USBC Rule 303).
9. **Entries close 4:00 PM, Sunday, August 3, 2025**
